Grooming Contract

Pets are accepted for grooming at Companion Camp, LLC under the following conditions:

1. The pet is in good health and is at least 12 weeks of age. Grooming for any animal with health-related problems will be at the owner's risk.
2. The pet has a current rabies vaccination and proof is presented at or before the time of the appointment.
3. Companion Camp, LLC will provide Pet Services, which are defined as reliable and trustworthy stewardship of pets to include climate controlled and sanitary conditions, fresh water and food, and a minimum of twice daily human interaction in keeping with like Department of Agriculture licensed pet boarding facilities licensed within the State of North Carolina. Companion Camp, LLC will exercise all reasonable precautions against injury, escape, accidents, or death of the pet. The owner will hold Companion Camp, LLC, its employees, officers, agents, and assigns free of all responsibility and/or liability for illness, injury, or death of his/her pet, the owner, or any person brought onto the premises of Companion Camp, LLC by the owner in the absence of gross negligence. The owner further agrees to be solely responsible for any and all acts or misbehavior of his/her pet(s) while in the care of Companion Camp, LLC, including, but not limited to, payment of costs for injury to staff or other animals or damage to facilities caused by the pet. Pet owners agree to indemnify Companion Camp, LLC with respect to any acts caused by the pet, the owner, or persons brought onto the premises by owner with respect to injury, etc., of other pets, property, or persons.
4. Pet owners will provide their personal contact information, emergency contact information, and veterinary contact information. In the rare event of an injury or health concern, Companion Camp, LLC will attempt to facilitate veterinary care with either the pet's primary veterinarian or with Companion Camp's on-call veterinarian. In such cases, pet owners agree to indemnify Companion Camp, LLC with respect to all pet medical care.
5. The owner agrees to pay all costs and charges for special services requested for the pet during the time the pet is in the care of Companion Camp, LLC. Uncollected pets will be charged a boarding fee.
6. The owner agrees to abide by all of Companion Camp LLC's policies, which are available in print or on our website and which change from time to time. Companion Camp LLC's policies are incorporated by reference as if fully set forth herein.
7. Dematting/thinning out of matted hair may cause patchiness and hair loss. Consent to remove matted hair is made with this understanding.
8. Shaving/stripping of pets may expose pre-existing skin problems. Written permission is necessary to perform this service.
9. Companion Camp, LLC will not release a pet to anyone, other than its owner, without specific instructions from the owner.
10. This Contract shall be governed by and construed in accordance with the Laws of the State of North Carolina with venue for disputes in Chatham County, North Carolina. Furthermore, this is our complete agreement with no other agreements beyond what is included within this document.
